ILLUSTRIA™ is a water-soluble fertilizer composition for foliar & in-furrow applications containing potash & other nutrients. ILLUSTRIA™ is designed to promote plant growth & quality. ILLUSTRIA™ provides additional nutrients to the plant.

COMMERCIAL USE ONLY

ILLUSTRIA™ is water-soluble & compatible with common nutrients & pesticides. For mixing, slowly add the amount of ILLUSTRIA™ directly into a partially filled spray tank with agitation operating. Do not apply ILLUSTRIA™ if rainfall is likely within 3 hours after application. The typical use of ILLUSTRIA™ in agriculture is a single application in-furrow followed by 1 to 3 foliar applications.

WARNING: ILLUSTRIA™ contains molybdenum (Mo).

The application of fertilizing materials containing molybdenum (Mo) may result in forage crops containing levels of molybdenum (Mo) which are toxic to ruminant animals. DIRECTIONS FOR USE

Foliar application

10-16 fl. oz./acre
10 - 60 gallons of water solution/acre or
50 - 400 gallons of water solution/acre for dilute applications.

Make first foliar application during crop's vegetative growth stage of development, prior to flowering. Applications can be made alone or tank-mixed with herbicides, fungicides or other foliar nutritional products. Repeat foliar application can be made on a 5-14 day interval.

For foliar use throughout the season including during herbicide and fungicide applications on the following crops:

- All edible food crops, crops grown for animal feed, and plants grown for flower or fiber.

Soil application: In-Furrow or Fertilization

10-16 fl. oz./acre
Apply at minimum 3 gallons of water solution/acre

For soil use on the following crops:

- All edible food crops, crops grown for animal feed, and plants grown for flower or fiber.

Compatibility with liquid fertilizers must be confirmed prior to application with standard Jar Test Procedure. ILLUSTRIA™ may not mix satisfactorily with high phosphorus & high sulfur content products.
